

Autumn 2019 Competition Terms and Conditions

Who is running the competition?	The Promoter is Camberwell Centre Association (ABN 42 467 190 205), P.O. Box 183 Camberwell VIC 3124.
When will the competition start and end?	The competition starts at 12.01 am (AET) on 01/03/19 and ends at 11.59pm (AET) on 31/05/19.
Who can enter?	Only Australian residents can enter.
Who can't enter?	Directors, officers, management and employees of: <ul style="list-style-type: none"> a) the Promoter; b) the agencies or companies associated with this competition or the Promoter; or c) the retail stores located in the Camberwell precinct, and the immediate families of those people, can't enter.
Where will the competition run?	The competition will run in participating stores (Store) in the Camberwell precinct, in Victoria.
Entry instructions	Visit http://camberwellshopping.com.au/competitions/win-1000-to-experience-camberwell-how-you-want/ <ul style="list-style-type: none"> a) fill out and submit the online entry form and all other requested information, to receive 1 entry into the prize draw.
How many winners will there be and how will they be chosen?	There will be 1 winner determined in respect of this competition. The draw will be held at 1pm (AET) on 03/06/19 at Warehouse 1a Glasshouse Road, Collingwood Victoria 3066. The first valid entry drawn randomly from the entries received during the Competition Period will win the prize. The Promoter may draw additional reserve entries and record them in order, in case the winning entry/entrant is deemed invalid.
What can I win?	There is 1 prize available. The prize is a shopping voucher valid at any Camberwell shopping precinct Store, valued at \$1,000 for the major prize draw. If you win, you must collect the prize from the Camberwell Centre Association office.

Entry

You will receive a return online message confirming your entry. The Promoter is not liable for any problems with communications networks. You are responsible for your own costs associated with entering. If you enter using automatically generated entries or multiple aliases you may be disqualified.

Prizes

- 3 Any voucher prize is subject to the conditions imposed by the supplier of voucher including any validity period.

General

- 4 If you are the winner, you must take part in all publicity, photography and other promotional activity as the Promoter requires, without any compensation. You consent to the Promoter using your name and image in any promotional or advertising activity.
- 5 If you or your entry are deemed by the Promoter to breach these Terms and Conditions, your entry (or at the Promoter's discretion, all of your entries) may be discarded. The Promoter may, at any time, require you to produce documentation to establish to the Promoter's satisfaction the validity of your entries (including documentation establishing your identity, age, place of residence and place of employment). Failure by the Promoter to enforce any of its rights at any stage does not waive those rights.
- 6 You must not:
 - (b) tamper with the entry process;
 - (c) engage in any conduct that may jeopardise the fair and proper conduct of the competition;
 - (d) act in a disruptive, annoying, threatening, abusive or harassing manner;
 - (e) do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this competition;
 - (f) breach any law; or

- 10 By entering, you request that your full address not be published.
- 11 If this competition cannot run as planned for any reason beyond the Promoter's control, for example due to software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, the Promoter may end, change, suspend or cancel the competition or disqualify affected entries/entrants, subject to any necessary approval by the state/territory gaming authorities.

- 14 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury, illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 15 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, or damage to, the prize.
- 16 The Promoter may communicate or advertise this competition using Facebook or Instagram. However, the competition is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. You provide your information to the Promoter and not to Facebook or Instagram. You completely release Facebook and Instagram from any and all liability.

Collection and use of your personal information

- 17 The Promoter may collect your personal information directly or through its agents or contractors. The Promoter will use your personal information to conduct the competition. The Promoter may disclose your personal information to its related companies, agents and contractors to assist in conducting this competition, communicating with you or storing data. By entering, you consent to the Promoter keeping your personal information on its database to use for future marketing purposes, including contacting you by electronic messaging.
